ORDER:

The Director of Indian Medicine and Homoeopathy, Madras has requested the Government to issue instructions for better administration and upkeep of Indian Medicine Wings attached to all the Allopathy Hospitals in the State.

The Government accept the proposals, The Director of Medical Services and Rural Health, Madras is requested to issue immediately the Circular annexed to this order to all Joint Directors and Deputy Directors of Health Services to ensure better administration, maintenance and upkeep of Indian Systems of Medicine Wards/Departments attached to allepathic institutions where the Indian system of Medicine and Homeopathy forms part and parcel of the Health Services, pointing out that any violation will be viewed seriously.
- 3. A report on the action taken in this regard may be sent to Government immediately.

CLHCULAR

I am directed to instruct you all to take appropriate action on the following matters raised by Director of Indian Medicine and Homogopathy and discussed in the meeting held on 17.5.95 at inector of Medical and Hural fiealth Services Office with Joint Directors and Deputy Directors of Health Services.

The Indian Medicine Wings viz. Siddha wings, Unani Wings and Ayurveda Wings are established in Government Headquarters Hospital, Taluk Headquarters Hospital. Non-Taluk Headquarters Hospital and Primary Health Centres. The Head of the institution of Allopathy system are the controlling officers and pay drawing officers and all the communications relating to the function of the Indian systems of Medicine Wings have to be sent by Head of Institutions who belongs to Allopathy side. The following bottle-necks observed in the day to day administration of the Indian Medicine Wings have to be tackled by the Allopathy Medical Officers as head of the institutions.

'A . Maintaining Attendance Register: 'V 'G '2L

It is found that the Allopathy Medical Officers are not exercising proper control over the maintenance of attendance register of Indian Systems of Medicine Wings and are not checking the punctuality of the Indian Systems of Medicine Wing staff. They are also very lenient in granting leave and encourage uncertainties absence which latter converted as duty by signing the attendance, by taking away the leave letter. They are very slack in sending communications to the districts siddha Medical Officers.

Even during the course of inspection, it is found that the staff members found absent from duty leaving a leave letter even without date and prior sanction of leave by the head of the institutions and later the allopathic Medical Officers go to the extent of protecting them as if they were on authorised leave thus nullifying the contents of the inspection reports. Thus, they are colliding themselves with unauthorised absentees subverting the discipline.

The Joint Directors and Deputy Directors of Health Services are hereby directed to instruct suitably the Allopathy Medical Officers to rectify the above defects.

2. Reply to Audit Reports:

A lot of Audit reports are pending for which replies have to be furnished by the Medical Officer (Allopathy) as head of the institution as well as drawing officers of the Indian Medicine Wings. These audit paras are left uncleared, resulting in large accumulation of Audit paras.

The Joint Directors and Deputy Directors are instructed to rectify this position.

3. Supply of Electricity, Drinking water, Diet, Allocation of Bed, Utilisation of Services of Basic Servants and Para-Medical Staff - Regarding.

It was brough to the notice that some of the Joint Directors and Daputy Directors are not co-operating and not even responding properly to the District Siddha Medical Officers in solving the issues relating to the day to day functioning of the Indian Systems of Medicine Wings.

The Government have already issued orders providing separate beds/wards for Indian Systems of Medicine in certain hospitals and also issued orders for reservation of 5/10 beds in hospitals where there are no exclusive Indian Medicine. Inpatient wards for providing treatment under Indian System of Medicine. However, in practice, it is found that the reservation of 5/10 beds in each one of the hospitals is not being honoured by the Head of the institution, with the result, the Indian Systems of Medicine lacks popularity among the public. The Accountant General while reviewing the performance of Indian Systems of Medicine, has pointed out the lacuna in not achieving the bed utilisation facilities despite the reservation made by the Government. Hence, the Joint Directors and Deputy Directors are instructed to allot 10 beds in respect of District Headquarters Hospital and 5 beds in respect of other hospitals, for providing In-Patient treatment under Indian Systems of Medicine, wherever Wings of Indian Systems of Medicine are functioning.

It is generally complained that the Indian Systems of Medicine Wings are not treated as part and parcel of the hospital but treated as a separate entity causing day to day administrative problems in maintaining wards and offering treatment to the patients. For instance, provision of diet, drinking water, services of Dhobies, Watchman in Inx-patient Department and Sanitary Staff to the wards and wings in Out-Patient Department under & Indian Systems of Medicine are completely reported to have been overlooked by the Allopathy Head of Medical Institution. This is totally unethical and unwarranted which requires immediate rectification.

The Joint Directors and Deputy Directors are informed that the Indian Systems of Medicine Wings and Wards are functioning as part and parcel of the hospital and all facilities extended to the Allopathy side are equally to be extended to the Indian systems of Medicine Wings/Wards and there should be no extended to the Indian systems of Medicine and the step-motherly discrimination as Allopathy or Indian Systems of Medicine and the step-motherly discrimination to the Allopathy head of the institutions need to be removed in total treatment from the Allopathy head of the institutions need to be removed in total treatment from the Allopathy head of the institutions and improvement of the District Siddha Medical Officerw for better maintenance and improvement of the facilities in Indian Systems of Medicine Wings.
