NOTE:

- c) No eligible candidate is available for 1 vacancy reserved for MBC/DNC - DAP – LV category and hence the same has been carried forward as backlog vacancy.
- d) The Appointment and posting order will be issued by the Commissioner, Indian Medicine and Homeopathy Department, Chennai – 106 separately.
- e) As per orders of the Hon'ble Supreme Court of India in Diary No. 65844/2025, dated: 16.12.2025, one general vacancy notified has been reserved for the respondent in the above case.
