ORDER:

In the Government orders first and second read above, orders have been issued transferring 81 posts attached with 64 Panchayat Union Dispensaries to Indian Medicine and Homoeopethy Department from Rural Development and Panchayat Raj Department with immediate effect.

The Special Commissioner of Indian Medicine and Homoeopathy, Chenna: in the letter third read above, has informed that out of the 81 personnel, only 72 persons are now available to provisionally absorb them in Government service on their transfer from the Department of Rural Development and Panchayat Raj and therefore requested the Government to transfer 72 persons to Indian Medicine and Homoeopathy Department from the Rural Development and Panchayat Raj Department, and to absorb them in Government service under Tamil Nadu Medical Service with effect from the date of issue of Government Order, subject to the verification of the Educational, qualification and age as per their service records

3. The Government have carefully examined the proposal and have decided to accept it. Accordingly the Government direct that the 72 numbers of Assistant Medical Officer and other staff of the panchayat union dispensaries indicated in Annexure I, II & til shall be transferred to the Department of Indian Medicine and Homoecpathy with effect from the date of lasue of the order, subject to the verification of educational qualification and age as per their service records.
