ORDER:

In the Government Order first read above orders have been issued for the establishment of an University exclusively for Indian Medicine and Homoeopathy.

2. In his letter 2nd read above, the Director of Indian Medicine and Homoeopathy has submitted a proposal for sanction of one post of Special Officer along with support staff for taking preliminary steps in the formation of the Indian Medicine and Homoeopathy University.

3. The Director of Indian Medicine and Homoeopathy has also suggested that the office of the Special Officer may function at initially at the building constructed for office of the State Licensing Authority at Tampcol herbal farm till the construction of buildings for the proposed University is completed. The services of the Sweeper-cum-Waterman already existing in the TAMPCOL Herbal Farm campus to be utilized for the Office of the Special Officer, Indian Medicine and Homoeopathy University, starts functioning.

4. The Director has therefore requested the Government to accord sanction the following posts for the Office of the Special Officer as detailed below:-

He has stated that the expenditure involved for sanction of above Staff and furniture for the office of the Special Officer is Rs.1,50,54,580/- (Rupees one crores fifty lakhs fifty four thousand five hundred and eighty only) out of which, Rs.86,52,080/- (Rupees eighty six lakhs fifty two thousand and eighty only) is recurring expenditure and non-recurring expenditure is Rs.64,02,500/- (Rupees sixty four lakhs two thousand five hundred only).

6. The Government careful examination have decided to accept the proposal of the Director of Indian Medicine and Homoeopathy and accord sanction for creation of posts of Special Officer and other staff as mentioned in Annexure-I of this order and also sanction a sum of Rs.99,18,685/- (Rupees Ninety nine lakhs eighteen thousand and six hundred and eighty five only) out of which, Rs.82,18,685/- (Rupees Eighty two lakhs eighteen thousand and six hundred and eighty five only) is recurring expenditure and non-recurring expenditure is Rs.17,00,000/- (Rupees Seventeen lakhs only) towards the creation of the post of Special Officer and other Staff mentioned in Annexure I to this order along with furniture and other items mentioned in annexure-II to this order.

7. The amount sanctioned para 6 above shall be debited to the following head of account:-

9. The Commissioner of Indian Medicine and Homoeopathy directed to send necessary proposal for appointment of Special Officer. He is also directed to send separate proposal for sanction of funds for the proposed new university buildings with estimate.




