Indian Medicine and Homoeopathy - Appointment of Tamil Nadu Medicinal Plant Farms and Herbal Medicine Corporation Limited (TAMPCOL) – Exclusive Nodal Agency for procurement and supply of all kinds of Indian System of Medicines - Orders - Issued.

### ORDER:

In the Government order first read above, orders were issued that all Government Pharmacies, Hospitals, Colleges and other institutions under the control of Indian Medicine and Homoeopathy Department shall purchase their crude drugs and herbal requirements only from the Tamil Nadu Medicinal Plant Farms and Herbal Medicine Corporation Limited (TAMPCOL).

2. In the letter 3<sup>rd</sup> read above, the Commissioner of Indian Medicine Homoeopathy and the Managing Director, TAMPCOL has stated that (i) TAMPCOL is engaged with the objective of carrying on the business of imports and exports in raw drugs, herbal drugs, animal and marine products, manufactured medicines, pharmaceuticals and market and sell these products in India as well as in international markets, either directly or through newly appointed agent/agents. (ii) It is working as



agents in all firms and branches of commodities, articles, products and merchandise or any kind of nature and is also supplying medicines under various health schemes of Government. Commissioner of Indian Medicine and Homoeopathy and Managing Director, TAMPCOL has also requested that the Tamil Nadu Medicinal Plant Farms and Herbal Medicine Corporation Limited, (TAMPCOL) may be authorized as an exclusive Nodal Agency for procurement and supply of all kinds of Indian System and Homoeopathy Medicines (Siddha, Ayurveda, Unani and Homoeopathy) / instruments, machineries and equipments requirements of all institutions functioning under the control of Commissioner of Indian Medicine and Homoeopathy and also requirements of Siddha, Ayurveda, Unani and Homoeopathy medicines of other institutions functioning in the State for their needs.

4. The Government, after careful consideration of the proposal of the Commissioner of Indian Medicine and Homoeopathy and the Managing Director, Tamil Nadu Medicinal Plant Farms and Herbal Medicine Corporation Limited, (TAMPCOL) have decided to appoint the Tamil Nadu Medicinal Plant Farms and Herbal Medicine Corporation Limited, (TAMPCOL) as Nodal Agency for procurement and supply of all kinds of Indian System and Homoeopathic Medicines (Siddha, Ayurveda, Unani and Homoeopathy) / instruments, machineries and equipments of requirements made by all the institutions functioning under the control of Commissioner of Indian Medicine and Homoeopathy and also the requirements of Siddha, Ayurveda, Unani and Homoeopathy Medicines of other institutions functioning in the State for their needs subject to the following conditions:-

- (i) Tamil Nadu Medicinal Plant Farms and Herbal Medicine Corporation Limited (TAMPCOL) shall follow the provisions of the Tamil Nadu Transparency in Tenders Act, 1998 and Tamil Nadu Transparency in Tenders Rules, 2000 and the amendments issued thereon.
- (ii) The quantum of service charges to be paid to the Tamil Nadu Medicinal Plant Farms and Herbal Medicine Corporation Limited (TAMPCOL) shall be decided separately after verifying the actual expenses incurred by the corporation at end of the year for this purpose.
- (iii) The Managing Director of TAMPCOL is permitted to release the quarterly Budget provision made for the procurement of the requirement to the respective Personal Deposit Account of the Managing Director, TAMPCOL as and when it is due and the Government may be addressed only when additional requirement of funds over and above the Budget provision are needed on the lines of Tamil Nadu Medical Services Corporation Limited, Chennai vide reference 2<sup>nd</sup> read above.
- (iv) Tamil Nadu Medicinal Plant Farms and Herbal Medicine Corporation Limited (TAMPCOL) should maintain a passbook system and necessary entries to be made as and when purchases are effected and supplied to



the concerned medical institutions coming under the control of Indian System of Medicines on the same lines of Tamil Nadu Medical Services Corporation Limited, Chennai.
