All the Joint Directors of Health Services / Deputy Directors of Medical and Rural Health Services and Family Welfare are requested to permit the District Siddha Medical Officers and Medical Officers (Siddha) to maintain separate Attendance Register for the staff attached to the Siddha Wings in Government Headquarters Hospitals, Taluk and Non-Taluk Government Hospitals and in Government Primary Health Centres, if it has not been done so hitherto.

I am to state that the District Siddha Medical Officers, Thoothukudi and Tenkasi have requested clarification regarding the maintenance of Attendance Registers of Siddha Assistant Medical Officers, Pharmacists and Hospitals Servants in the wings.

Necessary instructions had been issued to District Siddha Medical Officers from this Directorate to maintain separate Attendance Register in respect of the Siddha Wings in the Taluk / Non-Taluk Hospitals and Primary Health Centres. In some Districts there is no problem in maintaining separate Attendance Register. However, in some Districts, the Joint Director of Health Services and Deputy Director of Health Services have objected to the Maintenance of separate Attendance Register.

I am also to state that a separate Attendance Registers maintained by the Siddha Wings are to be closed by the Assistant Medical Officer and put up for the Counter Signature of the Medical Officer (Allopathy side). This procedure is necessitated to enable inspection of the Indian Systems of Medicine wings by the officials of the Directorate and District Siddha Medical Officer. In Siddha wings, attendance in the evening is also insisted during inspection and reference to Allopathy wings is, therefore, not practicable.

Hence, in order to have proper control over the Indian Systems of Medicine wings, they should be permitted to maintain a separate Attendance Register to be countersigned by the Medical Officer (Allopathy side).

In this connection, I request you to give suitable instructions to the Joint Director of Health services and Deputy Director of Health Services regarding the maintenance of separate Attendance Register in respect of the Siddha wings in the Taluk / Non-Taluk Hospitals and Primary Health Centres.

I request early action in this matter and instruction issued may kindly be communicated to this office.

The letter of even No. dated 4.5.06 may be treated as withdrawn.
