ORDER:

In the Government Order first read above the Government have approved the Selection list of Tamil Nadu Public Service Commission for 1999-2000 and issued appointment orders to 47 candidates (43 Siddha, 3 Ayurveda, 1 Unani) selected for the Post of Assistant Medical Officers in the field of Siddha, Ayurveda and Unani system of Indian Medicine.

2) The Commissioner of Indian Medicine and Homoeopathy in his letter second read above has stated that in the above said selection list in respect of Serial Numbers12 and 16 appointments where withheld by the Tamil Nadu Public Service Commission for want of community clarification. The Commissioner of Indian Medicine and Homoeopathy has also stated that necessary posting orders were issued to the selected candidates after duly verifying their antecedents with the police authorities and the above candidates have joined duty in the respective places and also certified that no disciplinary action is pending / contemplated against the 42 candidates and their work and conduct are also good and satisfactory. The Commissioner of Indian Medicine and Homoeopathy has requested to regularize the temporary services of 45 Assistant

Medical Officers consisting of 41 Assistant Medical Officers (Siddha), 3 Assistant Medical Officers (Ayurveda) and 1 Assistant Medical Officer (Unani) in Tamil Nadu Medical Services in the Government Order first read above.

3) After careful consideration of the proposal of the Commissioner of Indian Medicine and Homoeopathy to regularize the temporary services of the 45 Assistant Medical Officers consisting of 41 Assistant Medical Officers (Siddha), 3 Assistant Medical Officers (Ayurveda) and 1 Assistant Medical Officer (Unani) working in Commissioner of Indian Medicine and Homoeopathy Department mentioned in the annexure to the Government order, the Government hereby orders that the temporary services of the above mentioned Assistant Medical Officers, be regularised with effect from the dates noted against their names.
