### ORDER:

In the circumstances reported by the Director of Medical Education and Research, the following amendment is issued to G.O.(2D)No.131, Health and Family Welfare (A1) Department, dated.20.11.2007:

### AMENDMENT

Instead of the following existing clause in paragraph 2.1 of G.O. (2D) No.131 Health and Family Welfare (A1) Department, dated.20.11.2007, *Re-Counselling for filling up of the vacancies arising as a result of Counselling should be conducted seven days after the original date of counselling*, the following clause shall be substituted.

"There shall be three rounds of counselling in respect of transfer counselling, viz., First round – Counselling, Second round - Re-Counselling and Third Round – Mop up counselling. The three rounds of counselling shall be conducted on the same day itself."

2. In addition to the existing clause in paragraph 10.6 of G.O. (2D) No.131, Health and Family Welfare (A1) Department, dated.20.11.2007, the following clause shall be added.

### Transfer Counselling:

*Station seniority shall be calculated from the date of transfer / promotion orders issued by the Government / Directorate of Medical Education & Research. This calculation is applicable only for the purpose of transfer.*

*Provided that the aforesaid method of calculating station seniority shall not apply if there is willful delay on the part of Medical Officer in relieving from the old station or joining the new station on transfer/promotion.*
